The values in Column-BA of Worksheet-BoQ1 are automatically spooled in from other worksheets. Thereafter, you are required to fill in Column-M (Basic Rates column) with the Column-BA values in BOQ1 Worksheet only. Please Note that Cost of ESMP Compliance (in Worksheet-BoQ1) has to be filled in manually in Column-M which will automatically fill in Column-BA.
